• Collin must make it through his final three days of probation for a chance at a new beginning. He and his troublemaking childhood best friend, Miles work as movers, and when Collin witnesses a police shooting, the two men's friendship is tested as they grapple with identity and their changed realities in the rapidly-gentrifying neighborhood they grew up in.

### Selma (2014)

• This story shows Dr. Martin Luther King Jr. as he tries to secure equal voting rights by marching from Selma to Montgomery, Alabama in 1965.

#### The Hate U Give (2018)

• The story follows 16-year-old Starr Cater, who witnesses the murder of her childhood friend Khalil at the hands of the police and her journey towards activism. This movie was adapted from the book *The Hate U Give* by Angie Thomas.

In the years that follow, Stevenson encounters racism and legal and political maneuverings as he tirelessly fights for McMillian's life.
