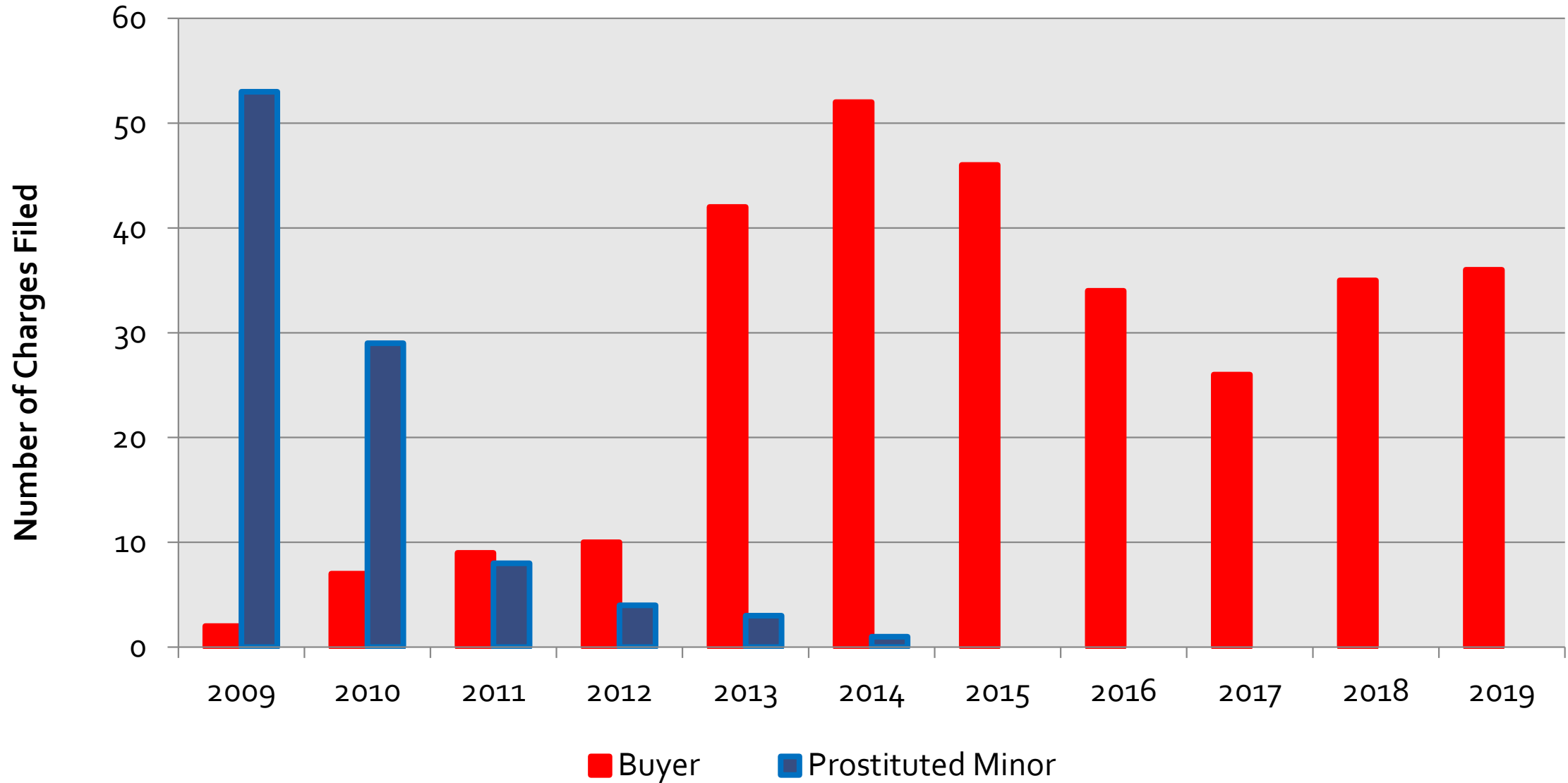

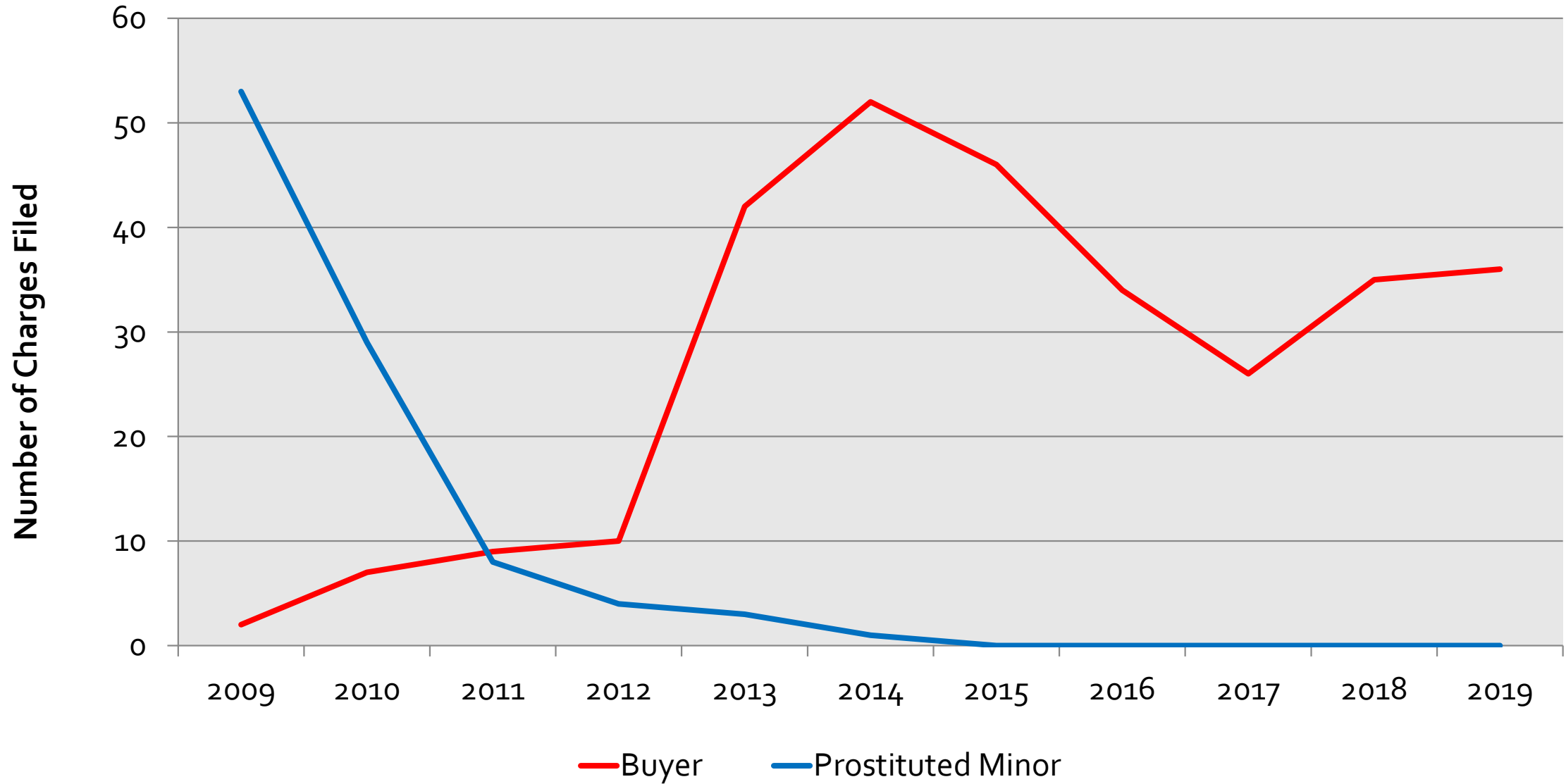


Minors Charged With Prostitution vs. Men Trying To Buy Sex From Minors



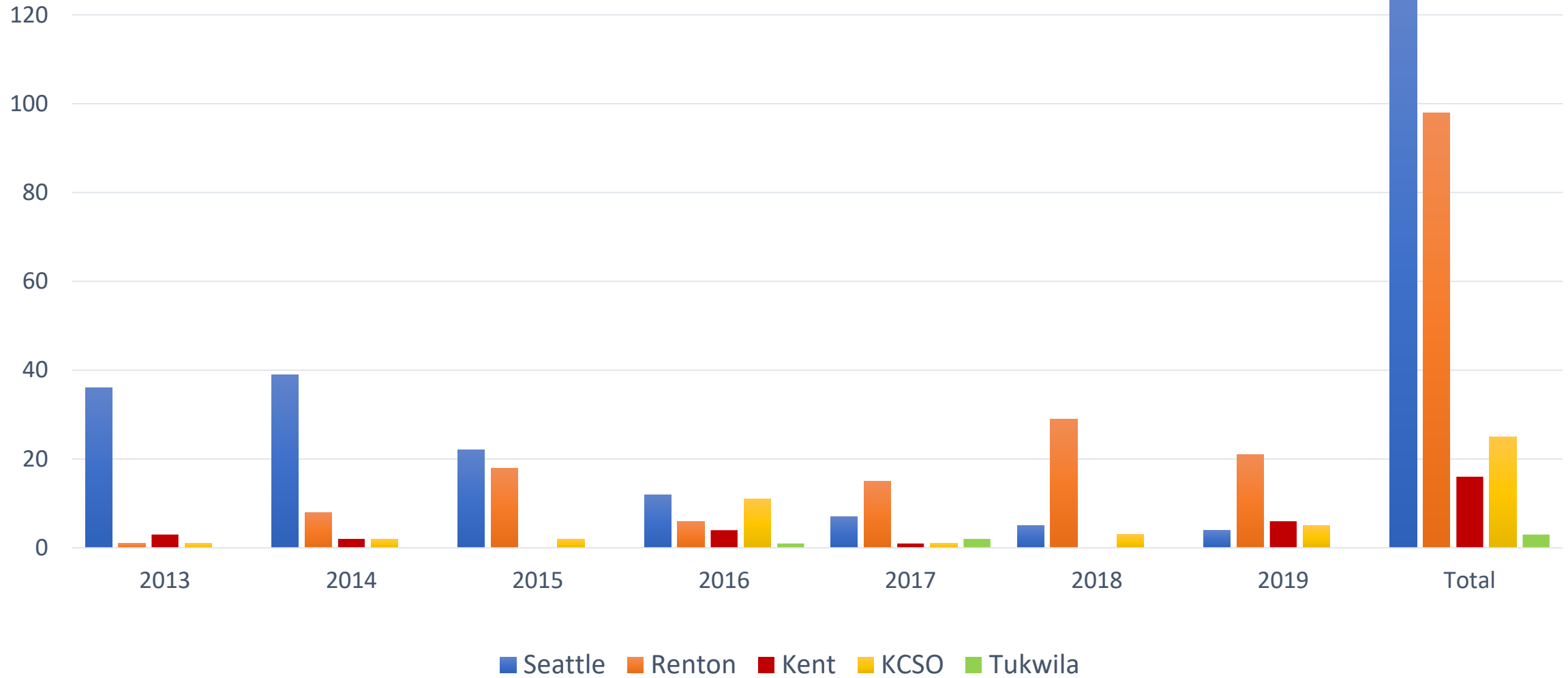

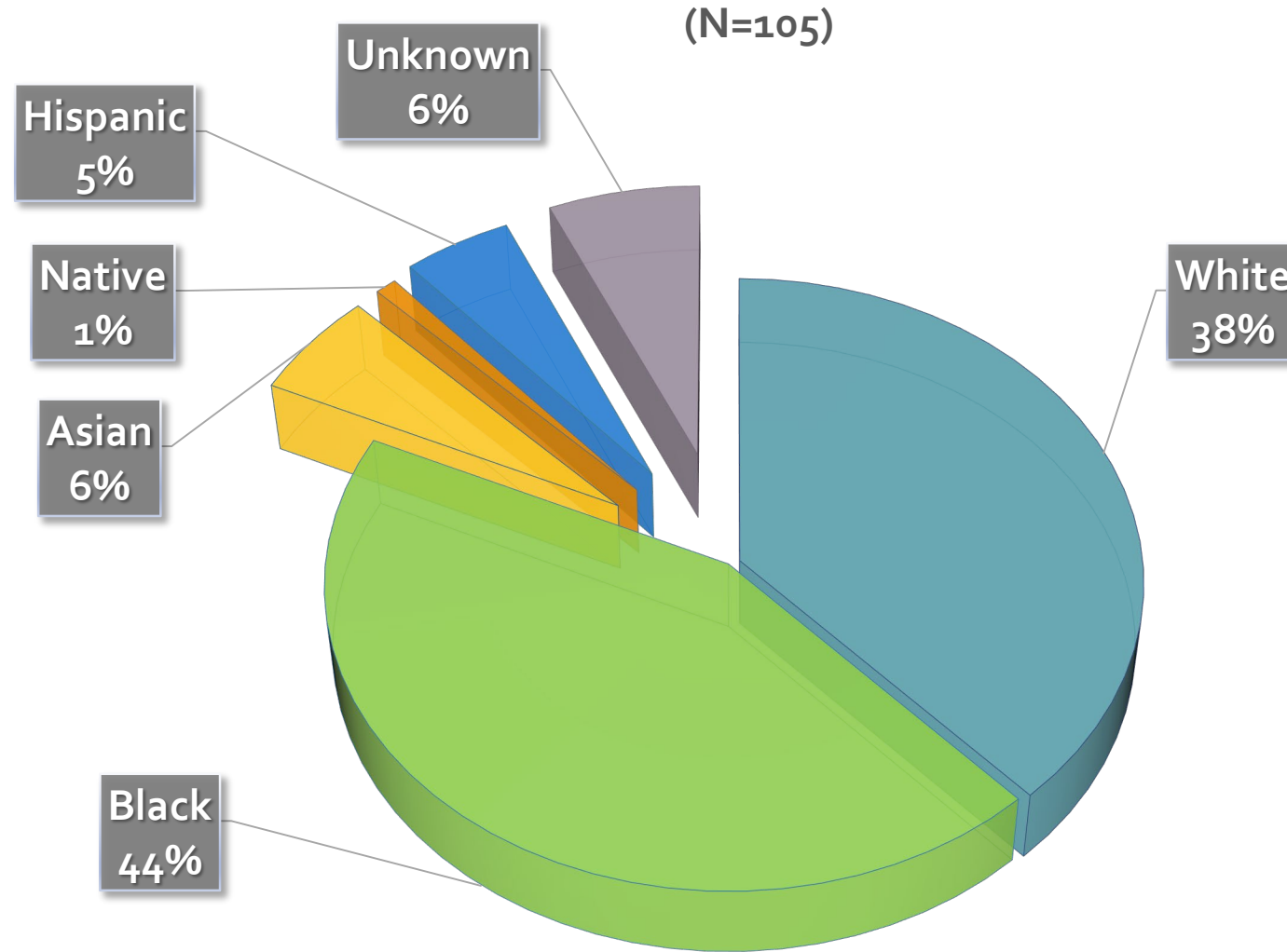


CSAM Cases by Agency 2013-2019





MINOR CSEC VICTIMS BY RACE: 2011-2019

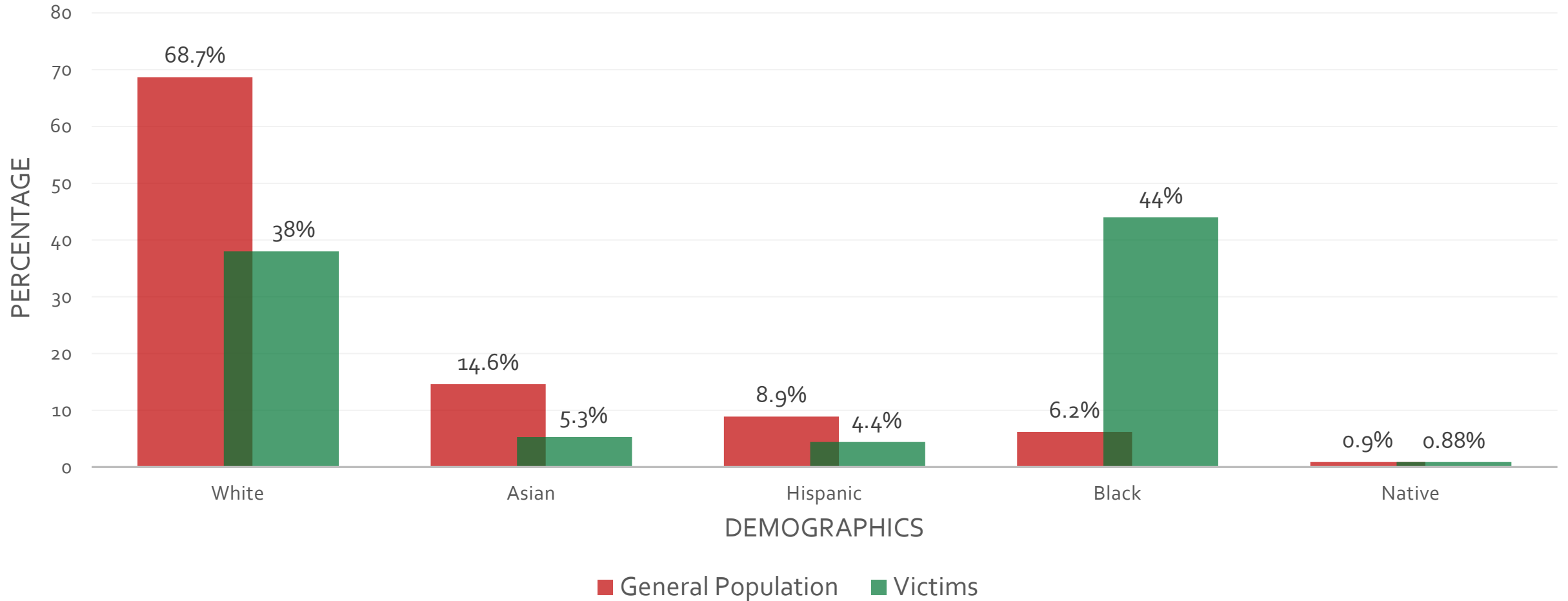

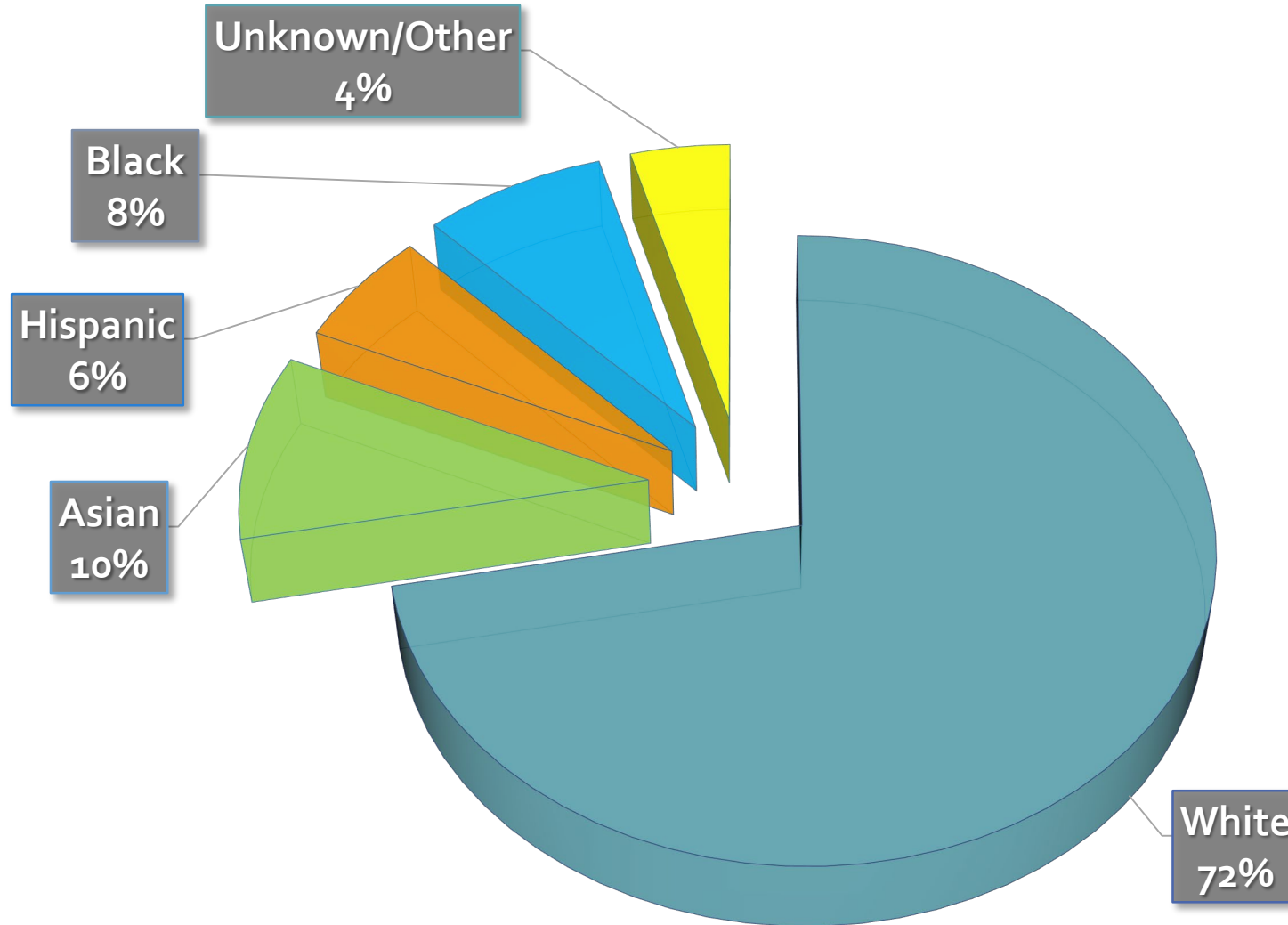

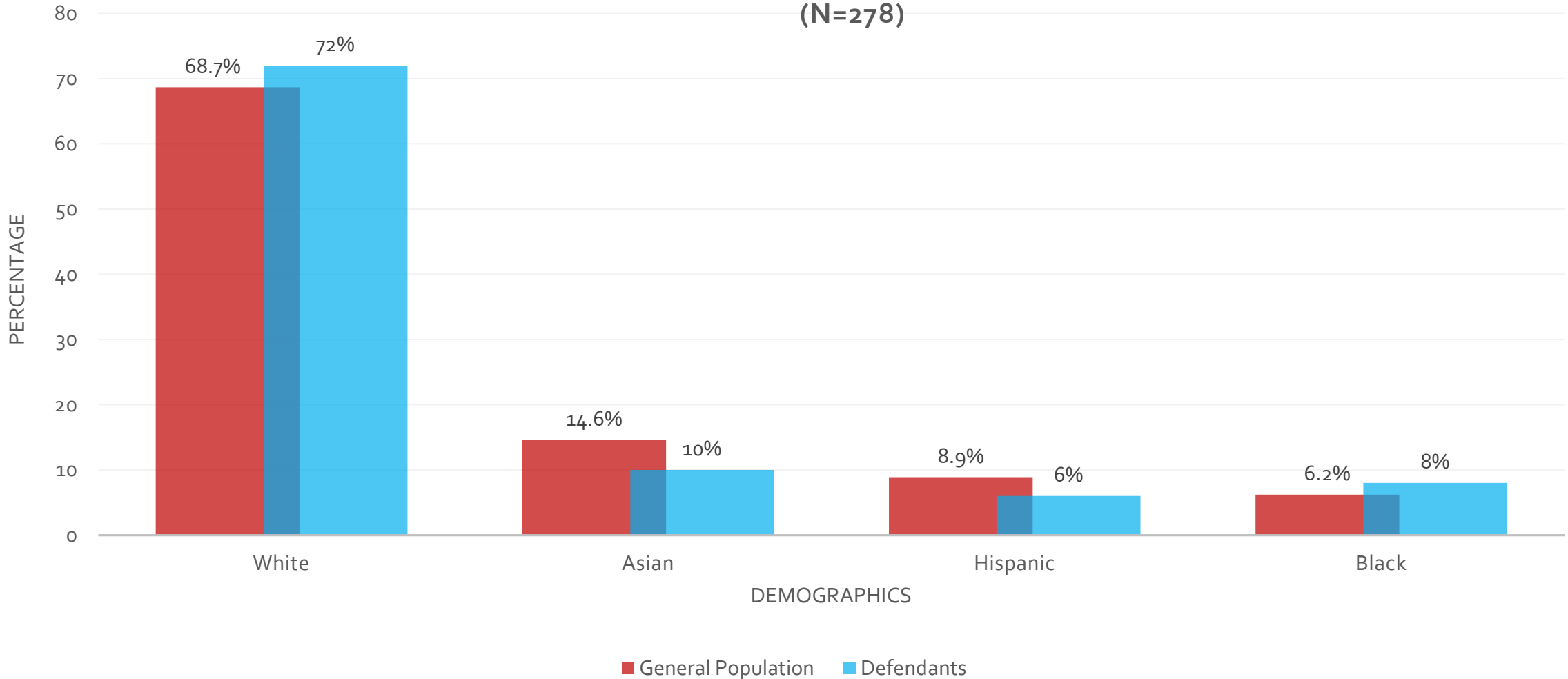

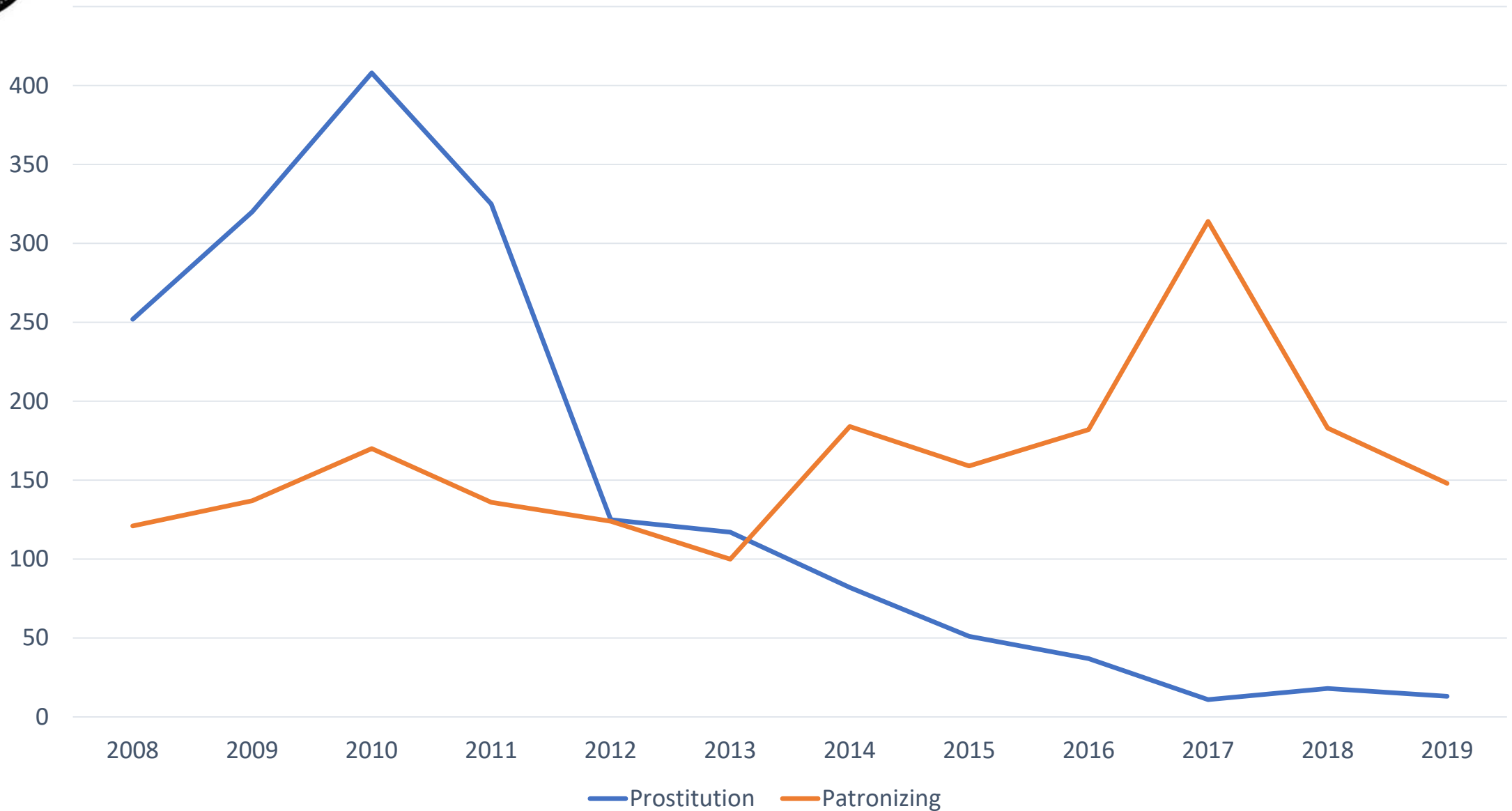

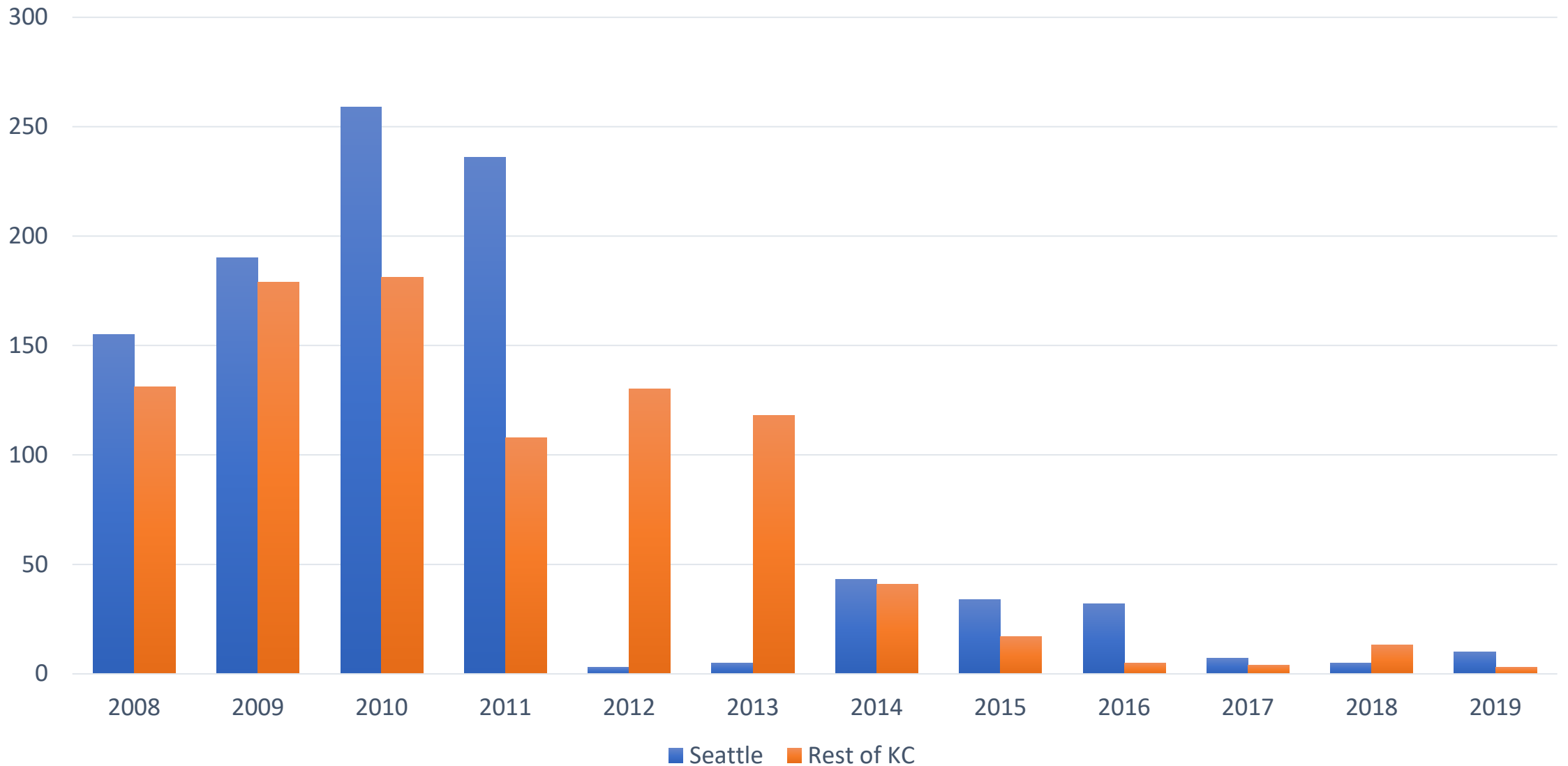

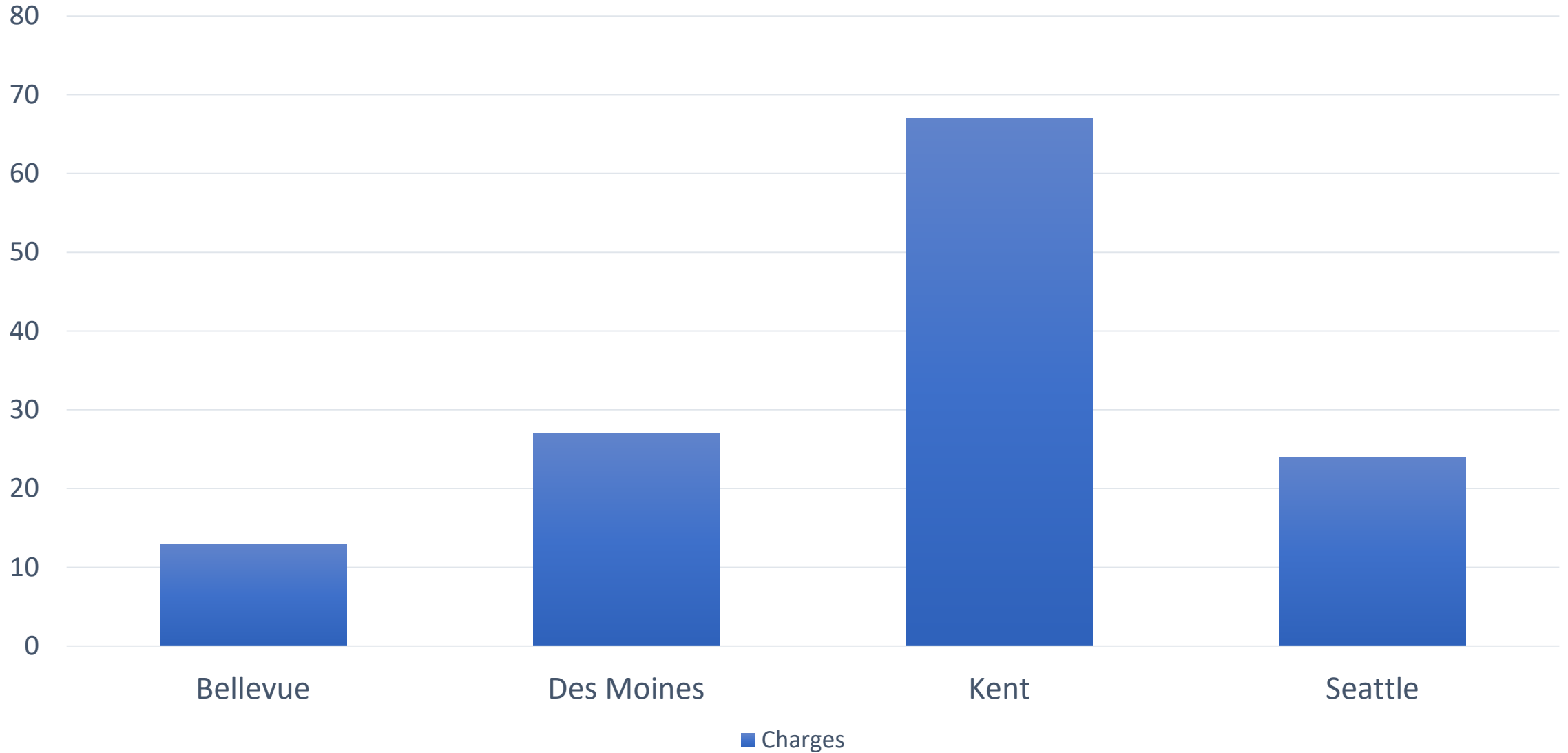
Prostitution Charges 2008-2019

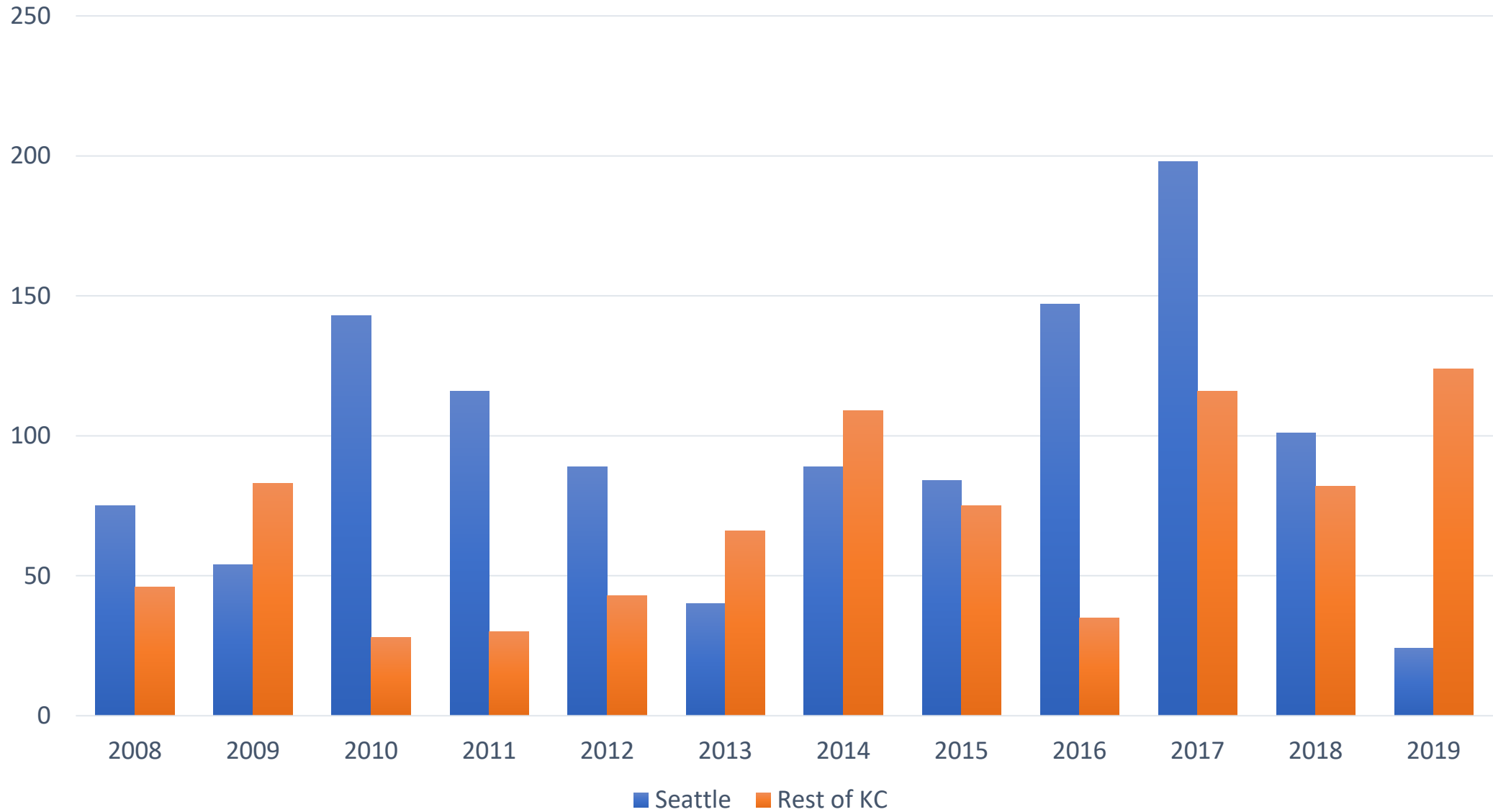
2019 Patronizing Charges by Agency

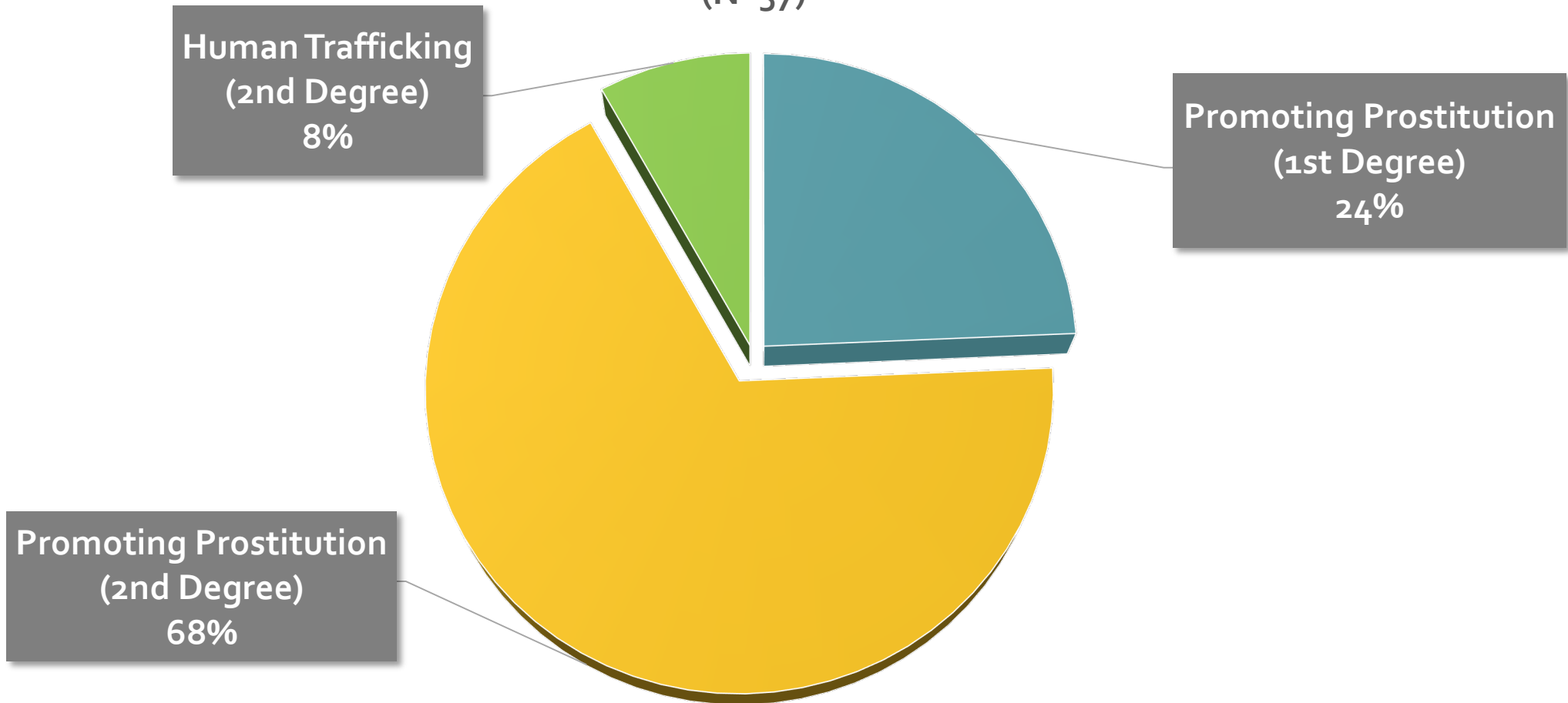


Adult Commercial Sexual Exploitation Charges for 2019

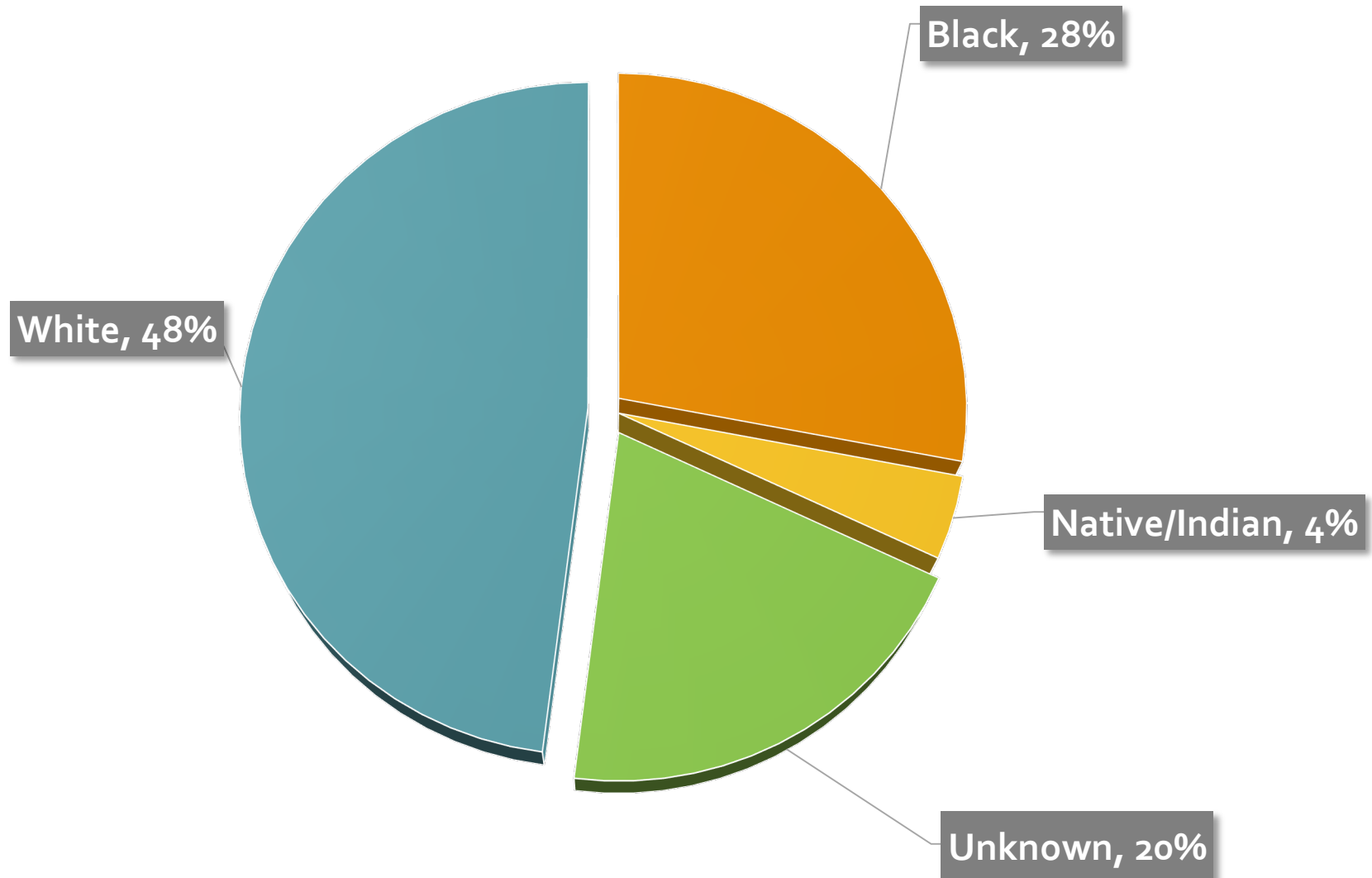

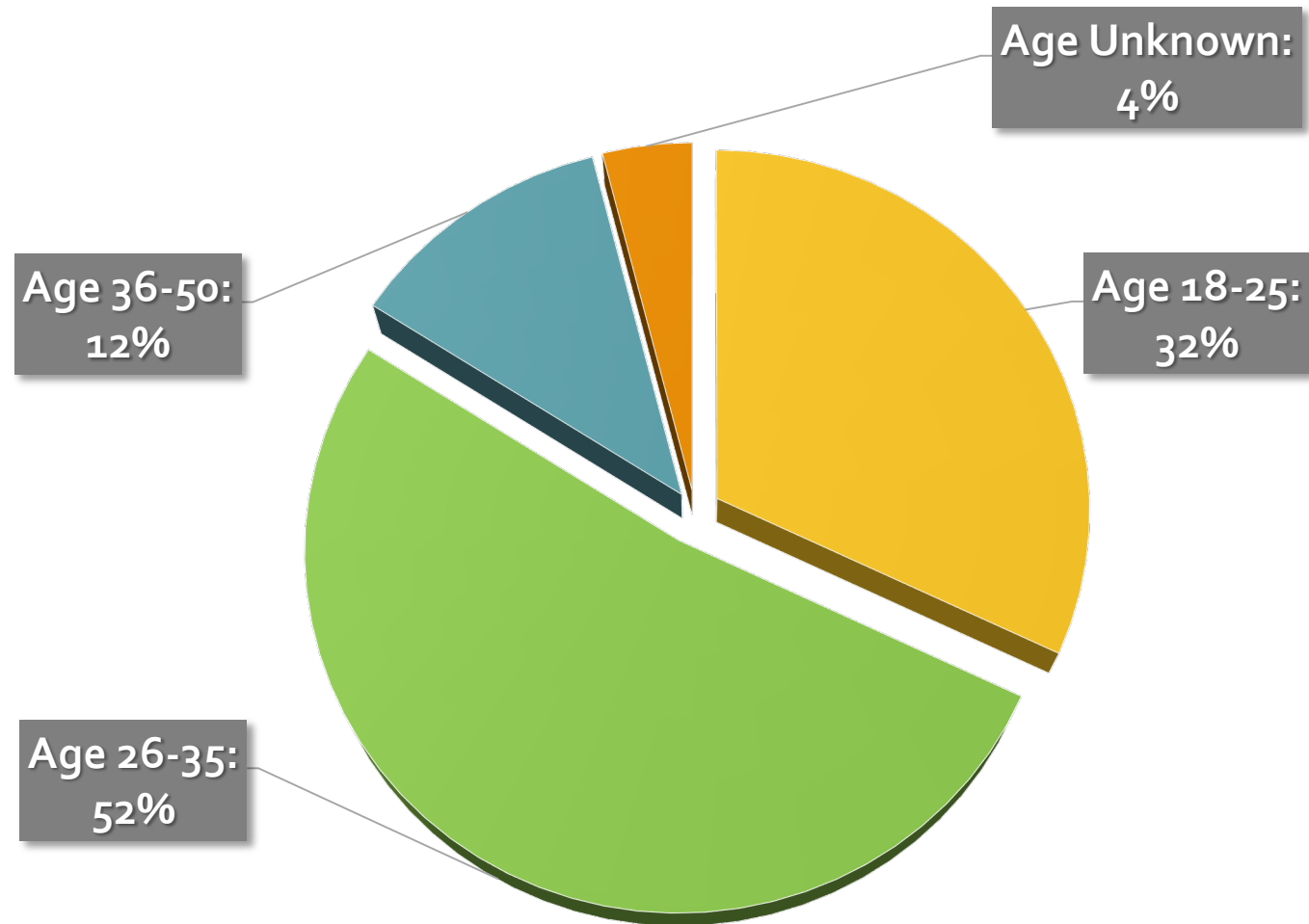

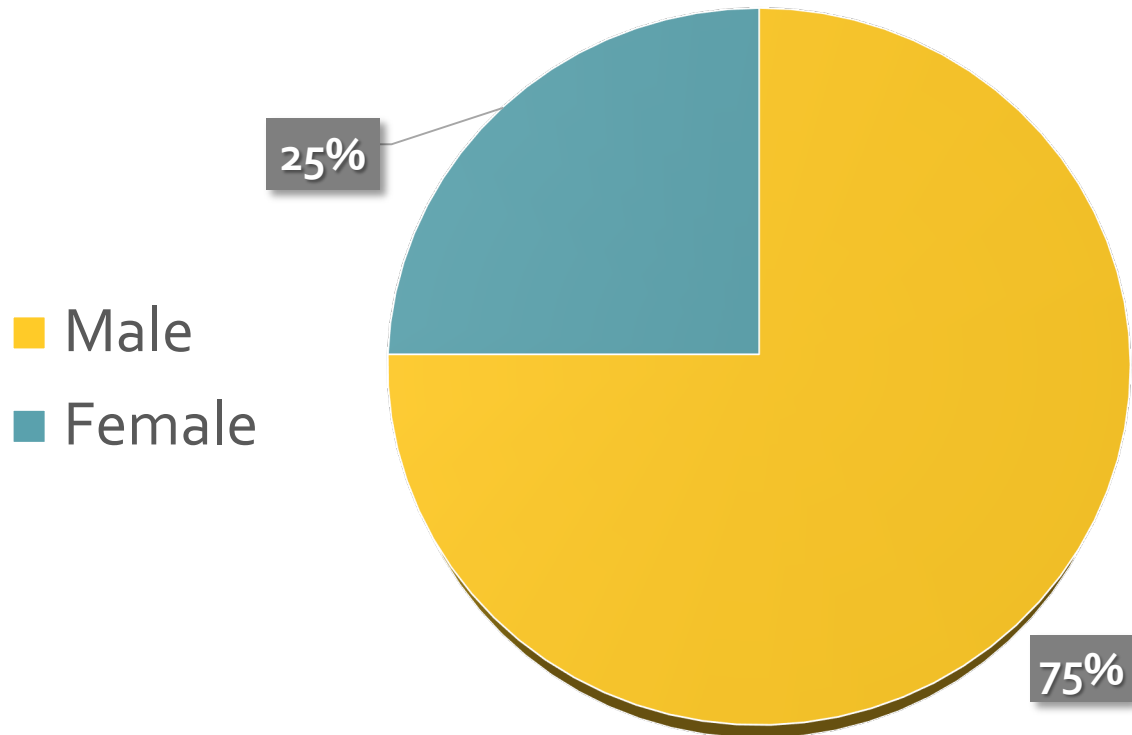

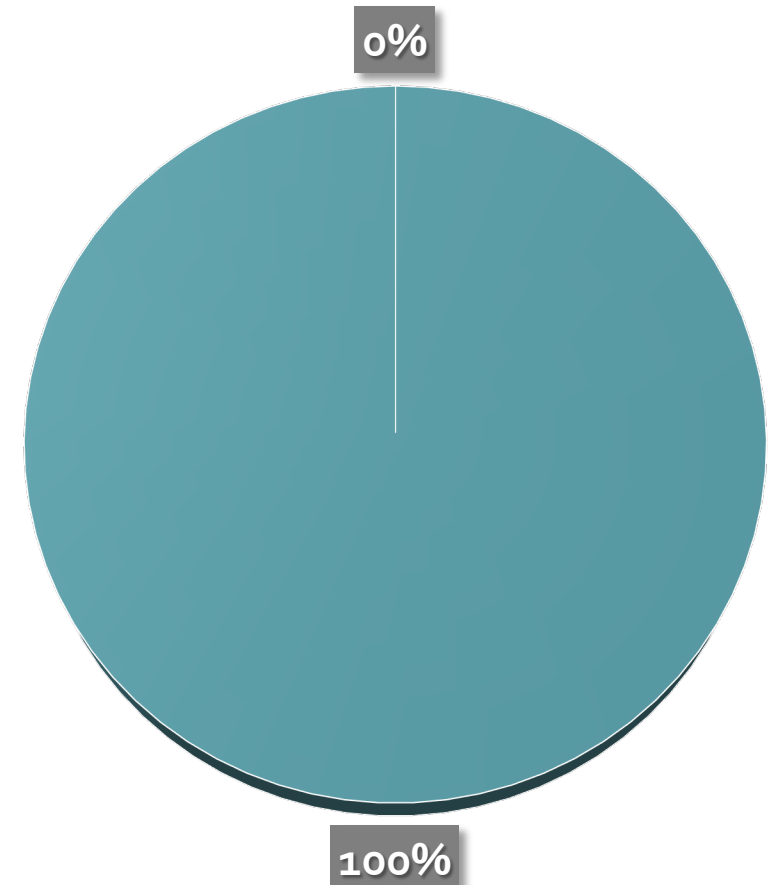


2019 ADULT CSE GENDER BREAKDOWN

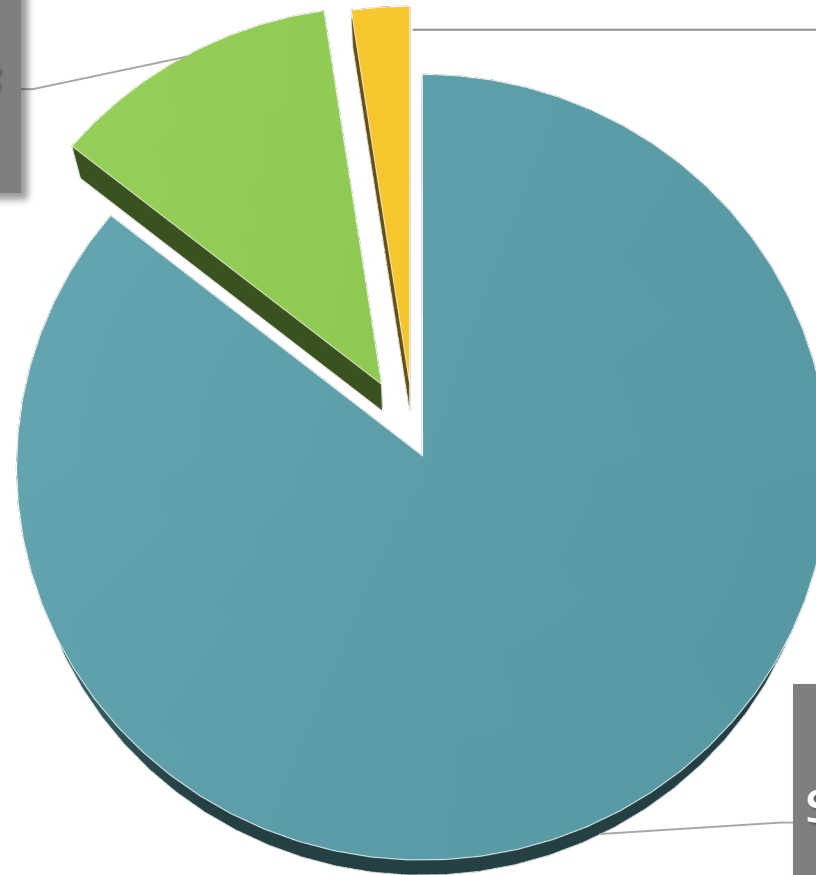

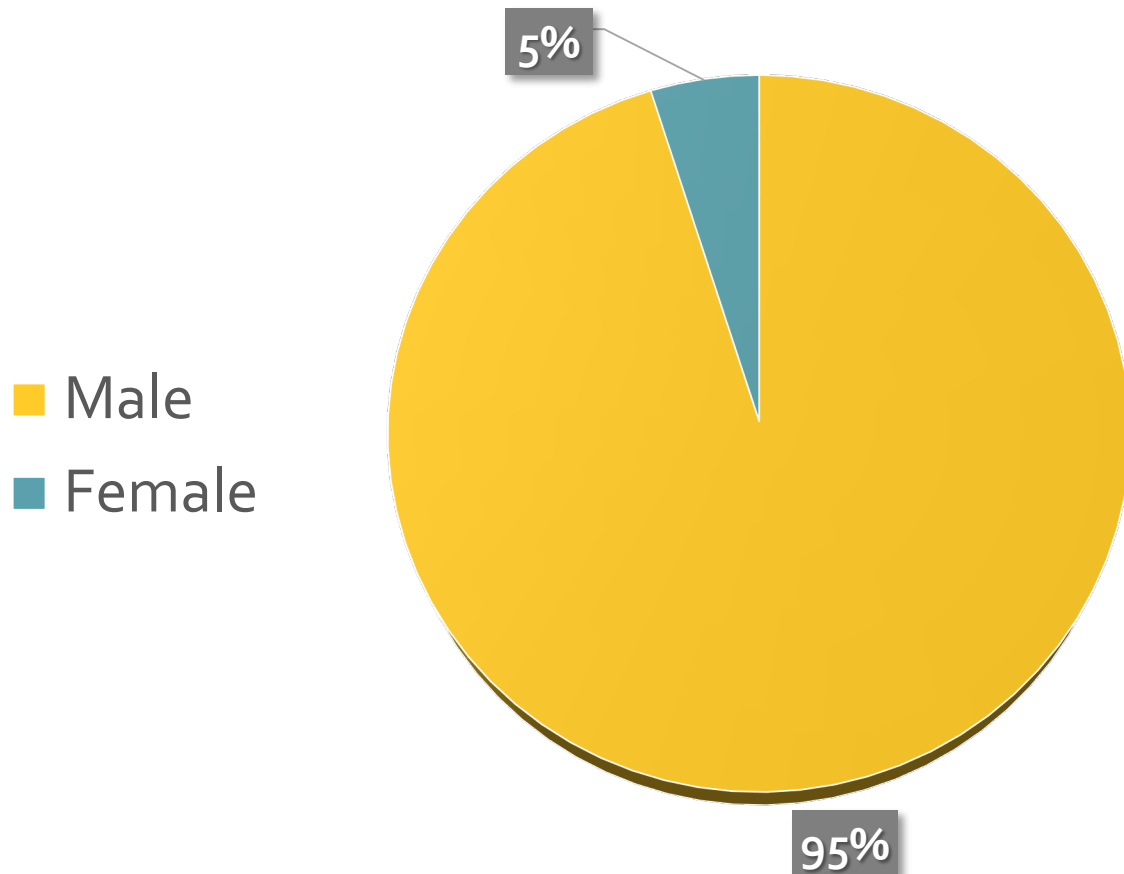

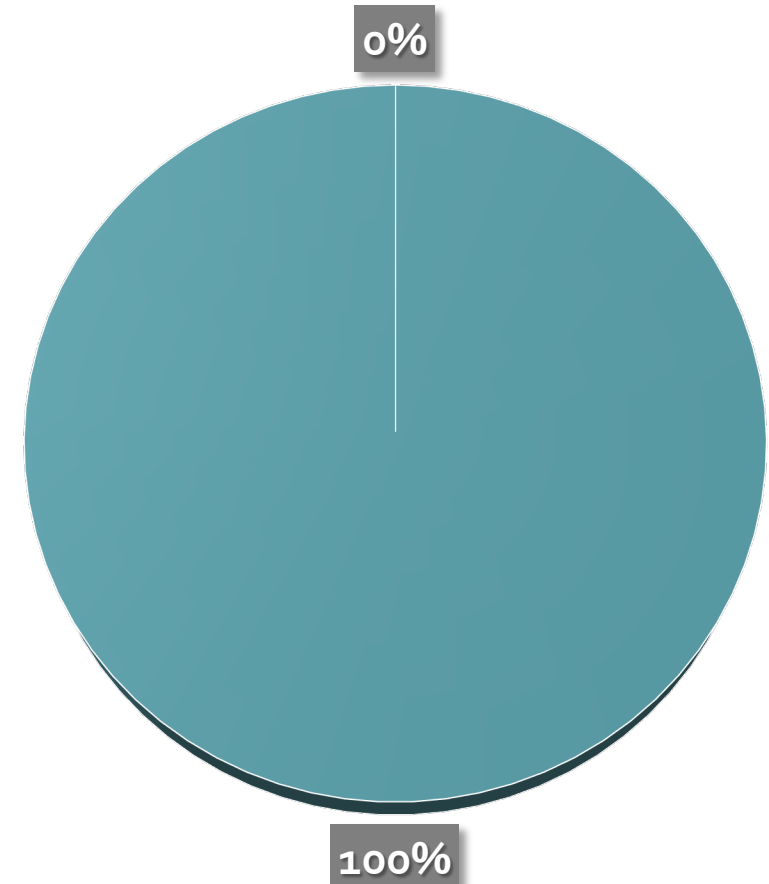


2019 CSEC GENDER BREAKDOWN

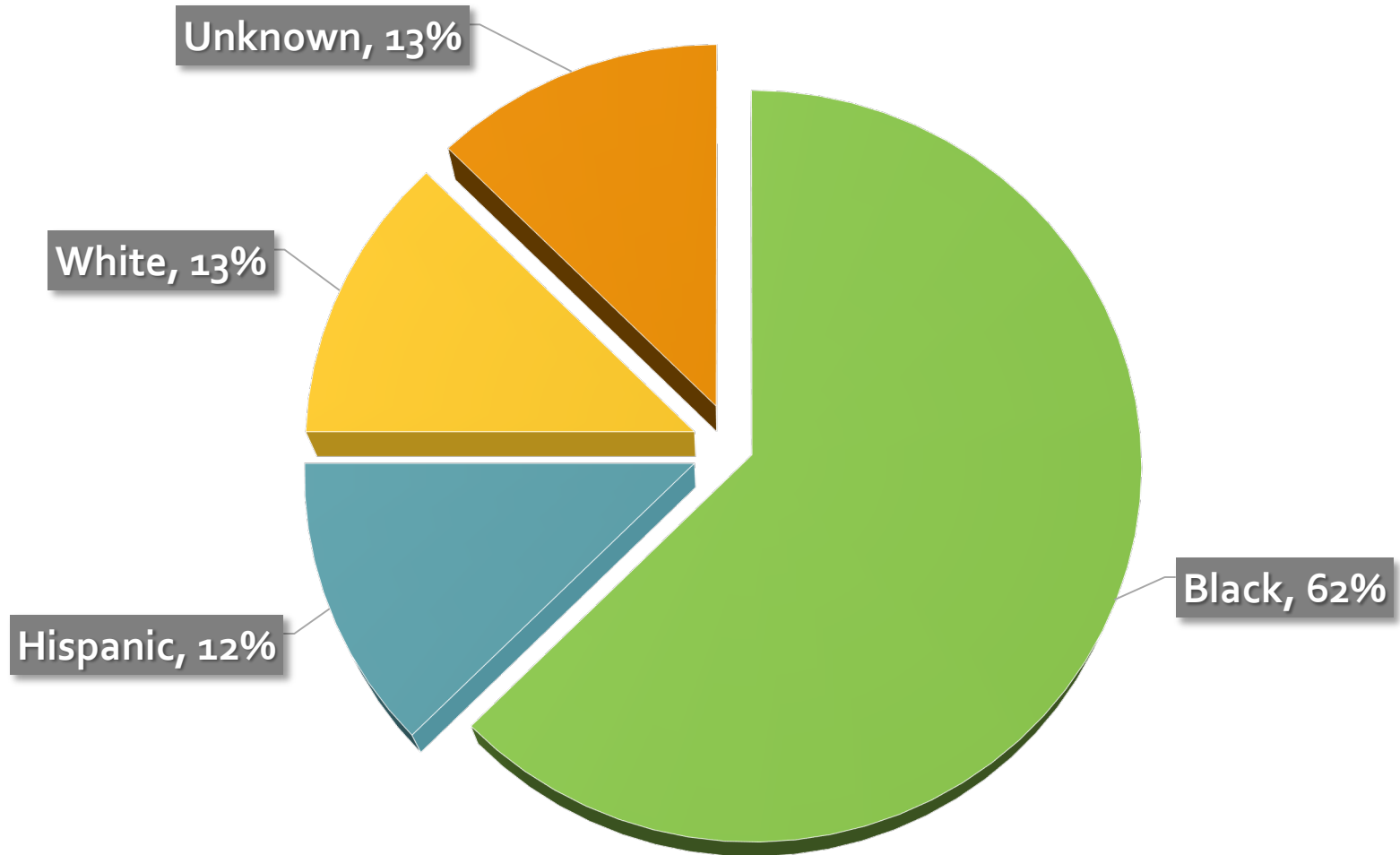

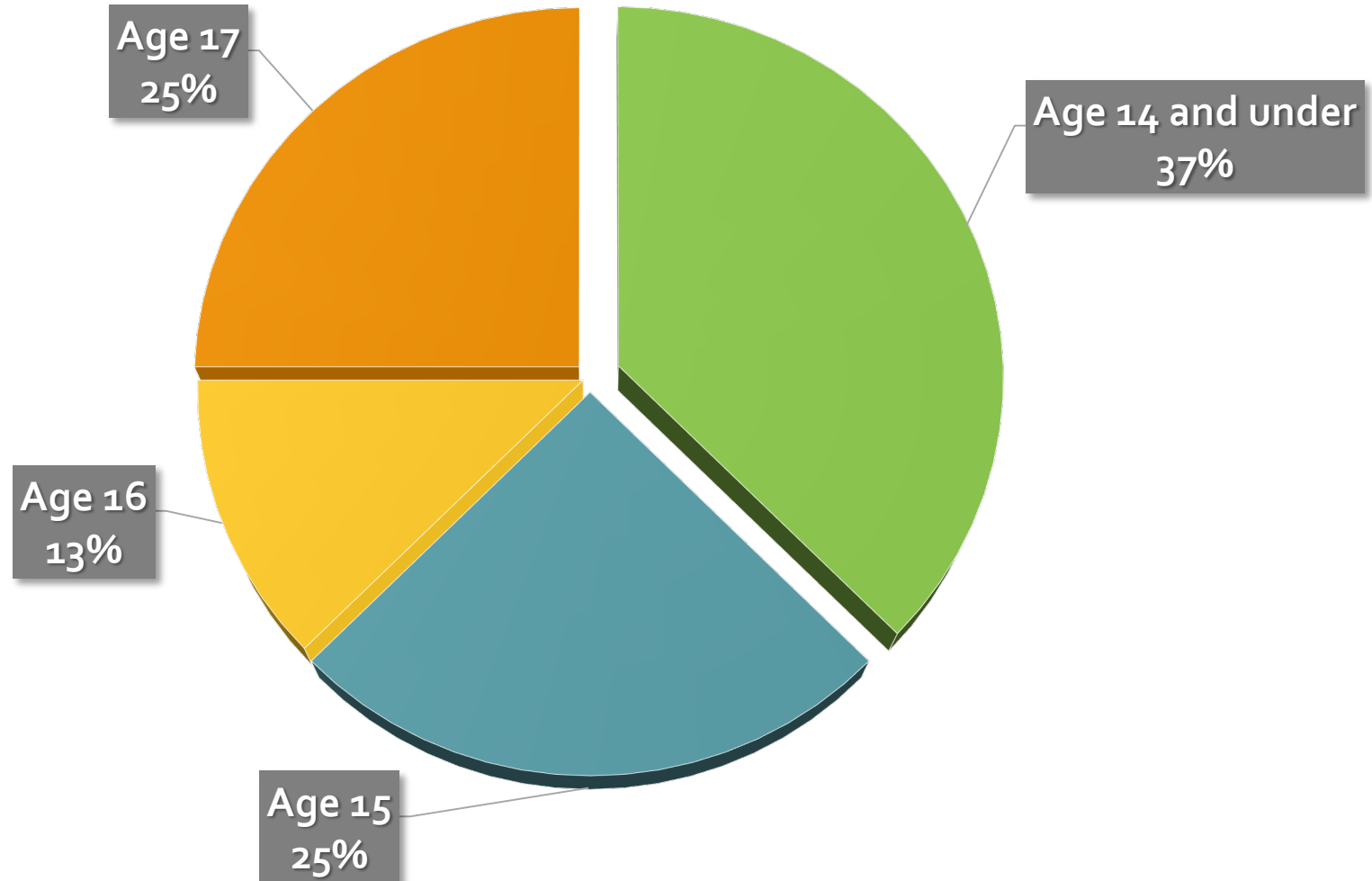

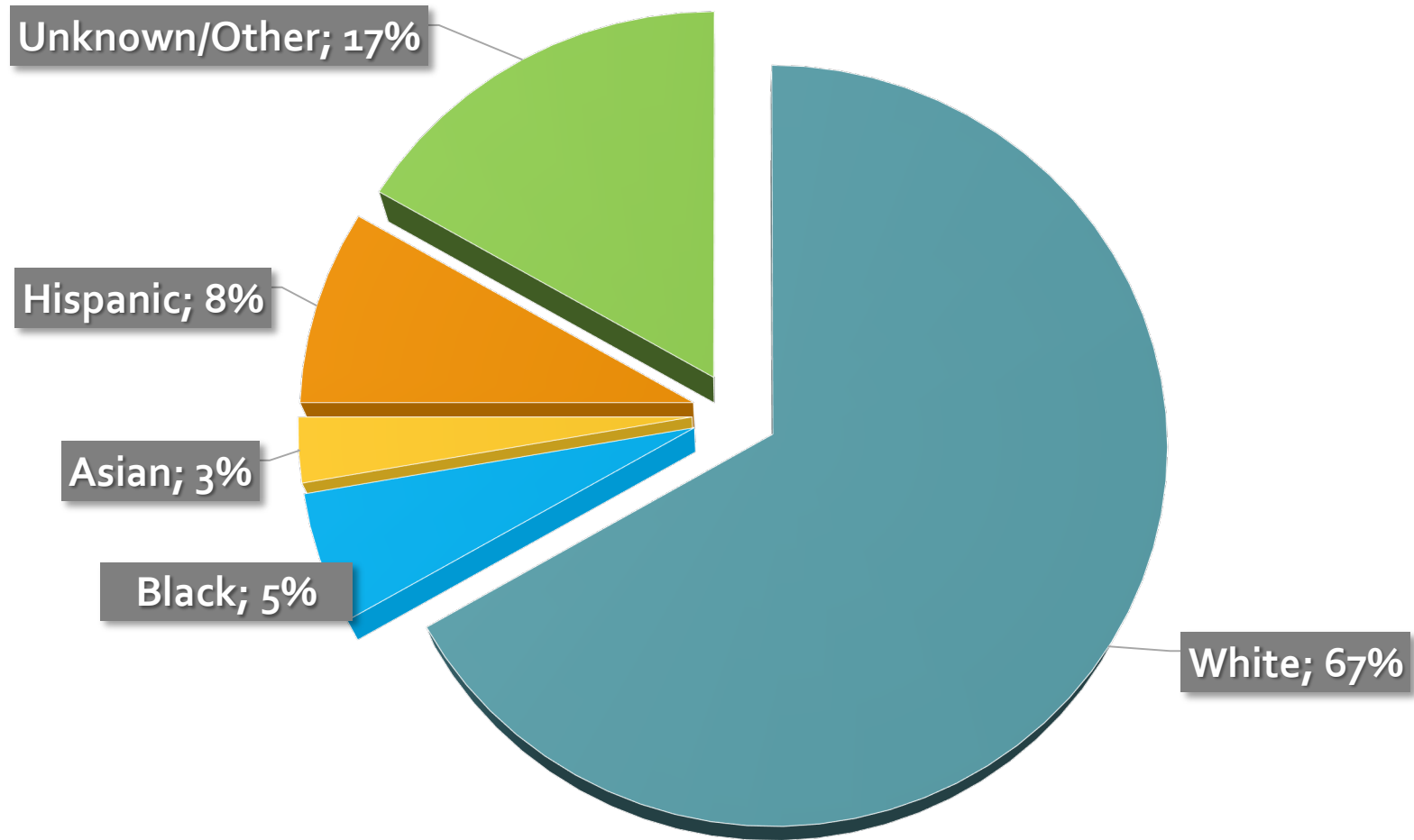
