referrals, community referrals.




Case Management

Strength based approach to inform and empower victim

Advocacy From the Beginning

Reporting

Information regarding process and rights and support in reporting process.

Safety Planning

Ongoing assessment of both physical and psychological safety through out the process.



Interviews

Preparation and support for interviews with Law Enforcement, prosecutors and defense attorneys. Provide information on victim rights and protect and advocate for victims' rights.





Advocacy in Action

Protection Orders

Assess available civil legal safety remedies available, help fill out and submit petitions and prepare and support victim at Protection Order hearings.

Decline Hearings

Advocacy support and facilitation of meeting with prosecutor to answer victim's questions, decision process explained and share any concerns. Providing victim direct access to the people making decisions on their case and providing possible closure.

Court Hearings

Provide in person support at all court hearings. Prepare and ensure victim right to be heard is upheld. Speak on behalf of victim when requested.
